Please Note: All children participating in *The Nutcracker* must be currently enrolled in the Fall Semester of classes at the San Diego Civic Youth Ballet.

AGREEMENT:

This Agreement is executed in favor of The San Diego Civic Youth Ballet, a not-for-profit CA corporation, its directors, employees, and volunteers (collectively, "SDCYB"). The Agreement is between the Dancer, Parent/Guardian of the Dancer, and SDCYB.

Injury Waiver: I, the parent/guardian for the above-named student, understand that the activity of dance can lead to injuries and I do hereby waive, release, absolve, indemnify and hold harmless, San Diego Civic Youth Ballet and the City of San Diego, for any claim arising out of any injury to my child. I further give permission for a SDCYB staff member, or other responsible adult to obtain whatever medical treatment necessary to preserve life or limb.

Production Fee: I understand that I will submit a **non-refundable** production fee with this form made payable to SDCYB. This fee helps to pay for expenses such as rehearsals, costumes, lights, sound equipment, etc. This fee is in addition to regular tuition. I understand that my child will not be allowed to participate in the audition /production if the production fee has not been paid. **The production fee is \$45.00 for Tiny Tots B – Level 2A (including Beg. Boys). The production fee is \$50.00 for Level 2B – 6 (this is due to multiple costumes and additional rehearsals at the upper levels).**

Dancer Photo/Video Release: By signing below, I grant permission for my Dancer to be photographed/videotaped. I also allow SDCYB to use any photos or video footage of my Dancer for SDCYB's website, newsletters, brochures, flyers, advertisements, social media, production programs, and all related communications. Please note, my signature on this form will override any photo/video release preferences I have listed on my Jack Rabbit Registration Form.

Toileting/Changing Policy: By signing below, I grant permission for my dancer to be assisted in toileting and changing clothing when necessary by an SDCYB Staff Member or parent volunteer. This signature overrides any toileting/changing preferences I have indicated on previous forms.

Rehearsals/Performances: I agree to have my Dancer attend all scheduled rehearsals. I understand that my Dancer may only miss two rehearsals and that if he/she misses more than two rehearsals, he/she may be removed from participating in the production. I also understand that all tech rehearsals, dress rehearsals and performances are MANDATORY. If my Dancer misses a tech rehearsal, dress rehearsal or performance for any reason other than a serious illness or family emergency, I know that he/she may not be allowed to participate in the next SDCYB production.

Lice Prevention Information: SDCYB uses an all-natural, peppermint oil based lice spray, called Licelogic, on all head pieces after performances. If you have questions about the use of lice spray, please contact SDCYB.

Parent Production Requirements and Guidelines:

As the parent or guardian of _____, I agree to fulfill a certain number of production shifts during *The Nutcracker* and agree to the following guidelines established by SDCYB:

- I agree to perform 2 production shifts. I understand that this requirement can be fulfilled by another person, such as a relative. Volunteers must be 18 years or older.
- I agree to show up on time for my scheduled shift and will not leave until I have been dismissed by a staff member or the Volunteer Coordinator. If I am more than 20 minutes late for my shift, I will be charged a \$20.00 late fee.
- I will sign up for the shifts by **November 18th** or my dancer risks not being allowed to perform in the production.
- It is my responsibility to confirm my production shift schedule by checking the Signup.com website myself. If there is a conflict I will contact the Volunteer Coordinator to resolve the issue.
- I understand that additional people, including children, are NOT allowed to accompany me to my production shifts. If I do not comply with this policy I will be asked to leave and my shift will not count. If I have a dancer performing, I may sign them in early in order to attend my shift on time.
- I understand that I will not be allowed backstage or in the dressing rooms unless my shift takes place in those areas.
- If I do not fulfill my parent production requirements, I understand that I could face a penalty of \$50 per missed shift (up to \$100).
- Volunteers are necessary to keep production costs low, therefore you may NOT simply pay this fine in lieu of fulfilling your production shifts. All families are required to sign-up for and perform their shifts in order for their dancer to participate in the performance.
